### **Amendments to the Rules and Regulations to the Association By-laws**

The following amendments to the Rules and Regulations of the By-Laws of the Association were approved in the Special General Body meeting held on 16/10/2022.

18 (a) the affairs of the Association shall be managed by a Managing Committee consisting of the following.

<ol style="list-style-type: none"><li>1) Vice-President</li><li>2) Assistant General Secretary</li><li>3) Six (6) M. C. Members</li></ol> <p>The above 8 posts shall be elected by the members of SBHREA of Twin Cities (Hyderabad) and R.R. District only.</p>
TELANGANA REGION
<ol style="list-style-type: none"><li>1. Vice-President</li><li>2. Assistant General Secretary</li><li>3. Three (3) M. C. Members</li></ol> <p>The above 5 posts shall be elected by the members of SBHREA of Telangana Region only Excluding Hyderabad and Ranga Reddy District.</p>
ANDHRA PRADESH
<ol style="list-style-type: none"><li>1. Vice-President</li><li>2. Assistant General Secretary</li><li>3. Two (2) M. C. Members.</li></ol> <p>The above 4 posts shall be elected by the members of SBHREA of A.P. Region only.</p>

KARNATAKA REGION
1) Vice-President 2) Assistant General Secretary 3) Three (3) M. C. Members The above 5 posts shall be elected by the members of SBHREA of Karnataka region only.
MAHARASHTRA REGION
1) Vice-President 2) Assistant General Secretary 3) 4 M.C. Members. The above 6 posts shall be elected by the members of SBHREA of Maharashtra Region only.

Total Executive Posts are 17 (Seventeen) Members since All Vice- Presidents and all Assistant General Secretaries of all Regions are parts of Central Executive Committee although they were elected by the members of SBHREA of their respective regions.

The Total Managing Committee Members are 35 (Thirty Five) (Executive plus M.C).

It was also resolved and approved that elections for the following Regions will be conducted at the respective regions within a period of 60 days from the date of elections of Central Office ie from 16/10/2022.

1. Telengana Region (Other than Hyderabad and Ranga Reddy Dist)
2. Andhra Pradesh
3. Karnataka
4. Maharashtra

Hence, elections for the Central Office and Hyderabad & Ranga Reddy Dist will be conducted today ie 16/10/2022.

The Managing Committee shall have the Right to Nominate any member of SBHREA at Metro centres wherever and whenever need arises. The Managing Committee shall also have the Right to Nominate and fill the vacancies arising out of exigencies by any member of SBHREA whenever it is required and wherever it is needed.

## **27 CREATION OF TRUST ACCOUNT**

The amount collected as Legal Fund and now held in SBHREA account shall be transferred to a separate Trust account and the trust so created shall be managed by a group of trustees who will be from the contributors to the legal fund jointly with 2 office bearers of SBHREA who are also contributors to the fund and it shall be decided by the Managing Committee members. The trust should be named as SBHREA Welfare Trust and the funds in the trust so created should be spent for legal expenses and for the welfare of the fund contributors only. The trust is created mainly for safe and effective monitoring of the funds.
