- 1. Taking stock of the slow pace of new registrations of membership in past two years because of pandemic, it was decided to reach all the retirees who have not become members of our esteemed organisation. - 2. The source of income to Association is membership fee and donations. Our Association takes one time membership fees and no other annual charge.
