## ANNUAL GENERAL BODY MEETING HELD AT CHHATRAPATI SAMBHAJINAGAR ON 23-06-2024

### **GENERAL SECRETARY'S REPORT**

Respected President, esteemed guests on the dais, my dear retirees/pensioners and family pensioners, all SBHREA leaders, invitees and members.

This organisation has a standing of 37 years and created a comfort zone for all members by attending to their benefits accrued, grievances redressed, problems solved with bank personnel and fighting for their legitimate and justifiable demands remaining unresolved and pending at the bank and industry level.

I, on my behalf and on behalf of the Managing Committee of SBH Retired Employees' Association extend a warm welcome to all the members of our Association for today's Annual General Body Meeting held outside Hyderabad for the first time in the history of SBHREA. This decision was taken in the Annual General Body meeting held in 2019.

Chhatrapati Sambhajinagar is the heartland of Marathwada, which is having second largest number of SBH retirees settled. We are indeed indebted to the Maharashtra team of the State Bank of Hyderabad Retired Employees' Welfare Pratisthan for taking the lead in organising the first AGM outside Hyderabad. This shall be a milestone conference.

It is my proud privilege to place the General Secretary Report on behalf of the Managing Committee. I am confident that deliberations in this meeting will go a long way in further building up the organization to new heights.

### **HOMAGE**

I record with deep sorrow and grief the passing away of a few leaders, veterans and members of the SBHREA. To name a few, Sri Vijay Marutirao Dhanurkar from Parbhani, Sri G. V. Nagabhushanam, former leader of SBHSA and SBHOA and chief patron to SBHREA and Sri G. Saibaba, President of SBHSA. After COVID causalities, age-related deaths took many lives of our members and their families. We extend our heartfelt condolences to the bereaved families. We pray to the Almighty to lay those souls in eternal peace. I request the house to observe a minute's silence.

### NATIONAL EVENTS:

ISRO bagged "Indian of the Year Award" for the year 2023 in the category 'Outstanding Achievement'. The award recognised the remarkable contribution made by ISRO in pushing the boundaries of space exploration. The year 2023 will undoubtedly be a historic period when India's Space agency demonstrated unparalleled prowess and resilience in the face of challenges. The pinnacle of ISRO's achievements in 2023 was the successful first-ever soft landing of Chandrayaan-3 on the Moon's uncharted South Pole region.

### **CONFERENCE OF G20 COUNTRIES IN DELHI:**

Holding the conference of G20 countries in India has been a very important event internationally. Global consensus has been arrived at on at least 100 issues after tense

negotiations among different nations for more than 200 hours spread over a couple of days without accusing Russia and Ukraine resolution has been taken asking all states to follow the UN charter that all the countries must abstain from threat or use of force to seek territorial acquisitions and honour the sovereignty of any state. A message has been given that a new global structure is needed for new realities. African Union is a new entrant in the G20 countries.

India has climbed many steps higher in the past 5 years, making India heading towards becoming World no 3. Let us celebrate this growth.

In the recent elections, NDA has made our beloved Hon'ble Prime Minister Sri Narendra Modi continue to lead the country with new zeal and enthusiasm. We wish to see our country grow by leaps and bounds.

### **MAGNIFICENT PERFORMANCE BY PUBLIC SECTOR BANKS:**

The spectacular performance of last 2-3 years of Public Sector Banks is a doom -to- bloom story, thanks to the reforms undertaken by Government. Resultantly, the 12 PSBs earned a total profit of ₹1,41,203 crore in FY 2024 out of which SBI alone contributed ₹ 61,077 crore which account for more than 40% or total earnings of all banks. SBI profit of ₹ 61,077 crore in FY 2024 is 22% higher than the previous financial year. PSBs is a turnaround story from record loss of ₹ 85390 crore in FY 2018 to record profit in FY 2024. Thus it is a matter of pride for us all as the bank is making robust growth on the strong foundation and pillars laid by all of us while in service.

### **REVISION OF FAMILY PENSION- AN HISTORIC ACHIEVEMENT:**

We waited for 36 long years, clubbed with struggles to see family pension revised to 30%, without a ceiling. This has benefited many family pensioners and gave the comfort to the pensioners. We are thankful to Madam Smt. Nirmala Sitharaman, Hon'ble Minister for Finance for her positive step in visualizing the woes of the family pensioners receiving a meagre family pension. Thanks to the combined efforts of many Retirees' Organisations who had put in their best efforts to achieve this task.

### **100% DA NEUTRALISATION TO PRE-2002 RETIREES:**

The anomaly existing in DA neutralisation for pre-2002 retirees was corrected. This benefit was paid w.e.f. 1.10.22 to all the retirees and family pensioners. DA at a uniform rate as applicable to the lowest basic pension in the existing DR frameworks, to all pre-1.11.2002 retirees (100% neutralization of tapered DR). This benefit though announced by IBA, has been achieved by the retiree's federations, with constant liaison with MOF. This is the second benefit bestowed in favour of retirees (out of the purview of BPS) and reflects the federation's liaison with MOF. This issue being resolved brought cheers to our senior members who have been receiving reduced pensions. Such announcements have ushered the hopes amongst retirees that MOF will definitely come up with an Updation of Pension in near future.

### **UPDATION OF PENSION:**

This is a long-awaited and justifiable demand pressed and followed up by many Retirees Associations/ Federations. The constant follow-up with the Ministry of Finance by Federations and questions raised by parliamentarians, memorandums submitted, emails sent to PM, FM and the litigations, which have reached the final stage and posted for final hearing have paved the way in achieving ex-gratia to all pensioners in XII BP residual issues. The ex-gratia is paid

from 1.11.2022. This was not welcomed by pensioner organizations until UFBU announced that this is not in lieu of Pension Updation. UFBU circulated a message that Pension Updation demand is still being pursued and that Ex-gratia is only for the present and revisable. The cumulative efforts put in for Pension Updation by all retiree organizations have given partial results in the form of Ex-gratia.

Every Pensioner in the Banking Industry is looking forward for the updation of pension, more so after extension of this benefit to RBI pensioners. There are positive indications that the Committees at IBA have been given necessary directions by the Ministry of Finance to submit its report. We are hopeful that NDA led Government will resolve our issues soon. Or else the Supreme Court of India judgement in the M.C. Singla Case should give this benefit which is very much awaited. The wait was too long and struggles, agitations, arguments, counter arguments on pension fund reserves etc., have been experienced by scores of pensioners. Wishful thinking is to see the Updation of Pension as per Reg 35, Appendix-1 is granted immediately by the new government. Otherwise, the fight through courts will continue until the updation of Pension is achieved.

### **NOTIONAL SENIORITY FOR VRS 2001 OPTEES:**

SBHREA will always be ready to support the Group of Petitioners fighting for the benefit of a larger group of retirees. Recently on request from Sri V. Sombabu and group, who have filed WP in the High Court of Telangana, SBHREA contributed ₹2,00,000/- to enable them to hire services of senior counsel. It was learnt that SBI was fighting this WP as a prestige issue, hiring an Advocate General. Hence this help had to be extended to see our advocate will not lag behind and bring favourable judgement. This is a decided case at industry level and SBI level. All PSB's and SBI has extended this benefit to SBM retirees only vide court orders. SBRA requests to extend the benefit to other left over eAB's met a deaf ear with SBI management. Hence, that being final hearing in the WP, SBHREA has taken a timely decision to extend the required monetary help and ensure favourable judgement is emanated with the help of senior counsel. This WP is posted to a further date in June 2024.

### **SUBMISSION OF MEMORANDUM TO CIRCLE HEADS:**

A memorandum was submitted to CDO, Amaravati and other circles by leaders of SBRA and SBHREA with great enthusiasm. The call of SBRA was taken up by all Associate Banks. In SBH Large number of retirees belonging to all cadres have participated with full zeal and enthusiasm. The memorandum highlights the discriminatory nature of service towards eAB retirees and their problems by SBI management and staff. The memorandum was addressed to the Chairman and submitted through Circle CDO by individual retirees. The emphasis was to seek concurrence on extending Structured Meetings separately to eAB Retirees Associations to enable them to represent their grievances. The bank has no mechanism to know eAB retirees' specific grievances. This issue can be resolved only by hearing eAB retirees through their representatives. The support and solidarity shown by members to this call was commendable and the impact created was unbelievable. Kudos to the member's enthusiasm to be part of the struggle and SBHREA wholeheartedly thank every member who participated in this memorable event from this Dias.

### **REMOVAL OF PENSION CEILING IN SBI:**

SBI pension ceiling was challenged in the Hon'ble High Court of Delhi by their Federation in the year 2013. The case was last heard in May 2020. Thereafter, SBI Pensioners' Federation

appealed to the Chairman of State Bank of India on 06-01-2021, to take up the matter with the Department of Financial Services, Ministry of Finance. SBI Chairman took up the matter with the Government of India, providing necessary information time and again and the issue was resolved by the Government of India this year 2024. We congratulate SBI Management for taking the lead in solving long pending demand to bring equality amongst SBI Pensioners.

This is giving rise to a demand by few activists to demand PF as third benefit to all Bank retirees. We need to mention here that we SBH retirees are bound by the Pension Regulations of 1995 (called IBA Pension). We need to go by the provisions of our Pension Regulations 1995. Anyhow, this will be a matter of study by our veteran leaders who shall guide us and the Federations we are affiliated to, shall take up the matter.

### PENSION OPTION FOR RESIGNEES:

This is another landmark achievement. After 2 decades of persuasion, the Resignees are being given pension option. Circular instructions are yet to be released by all PSBs. We welcome the Resignees to join SBHREA.

### OTHER PENSION RELATED ISSUES UNDER CONSIDERATION:

There are number of issues which are to be resolved. We have been making sincere efforts for improvements/rectification of anomalies in the following areas:

- a) Improvement in Pension Commutation formula and reduction of commutation period.
- b) Enhancement of Pension to Old SBH pensioners (joined before 1959).
- c) Funeral expenses to be restored.
- d) 5 years Notional Seniority to 2001 VRS optees.
- e) Bank PF to be paid from date of appointment to SBH retirees who opted for SBI pension.
- f) Study to take over the Special Allowance case filed by GOP from SBH, as the WP has been clubbed with similar cases and is posted to Delhi High Court.
- g) Study to take over Gratuity cases once they cross a single bench in High Courts, if prospective chances are expressed by legal experts.
- h) Efforts demanding Structured Committee meetings with eAB Retirees organisations.

### **OUR AFFILIATIONS TO ALL INDIA RETIREES FEDERATIONS:**

### AIBPARC: (All India Bank Pensioners' and Retirees' Confederation)

The leaders of SBHREA are participating by taking positions in both the All India Retirees Organisations. After the expansion of our cabinet to all 5 areas of operations i.e. Hyderabad, Maharashtra, Karnataka, Telangana and Andhra Pradesh, some of the Office bearers from those areas have taken up positions in AIBPARC state units and playing a vital role.

AIBPARC is the largest All India Retirees organization taking the lead in following up with IBA, UFBU, and MOF on all issues with continuous correspondence and liaison with their executives. AIBPARC has led thousands of members to send multiple emails to concerned dignitaries who matter in resolving bank retirees' issues, by which much pressure was mounted on the concerned. All Banks retiree organizations were made to participate in centralized dharnas organized by AIBPARC. In the past 2 years, the long pending benefits derived prove the organizing and management skills of the organization. One more pension option for the resigned is the latest addition to the list of demands achieved.

Com. K.V. Acharya, President and Com. Suprita Sarkar, General Secretary are making relentless efforts to clinch the following benefits viz., Pension reforms, restoration of commuted value of pension, qualifying service for full pension, and Pension Updation. AlBPARC was the first to come out and say ex-gratia is not a substitute for Pension Updation. The court case about Pension Updation is being followed up by legal luminaries in AlBPARC. President and GS are pursuing with MOF to see Pension Updation is implemented in lines of RBI, quoting Reg 35 (1) of Pension Regulations 1995. AlBPARC succeeded in bringing All India Retirees Federations together to demand Pension related issues to be discussed with them by IBA. Very soon the All India Retirees Federations will be negotiating the issues related to bank pensioners and retirees

### **SBRA: (STATE BANK RETIREES ASSOCIATION)**

This federation was formed in 2019 as umbrella organization for 7 Associate Banks merged with SBI, to protect the privileges/rights of erstwhile Associate Banks and nullify the discrimination being meted to eAB retirees by SBI management. Our leaders Dr. A. Ananta Krishna Rao, President and Sri V. Sombabu, Joint General Secretary are leading the organization along with Sri C.N. Prasad the GS of SBRA. Few more office bearers are from SBHRFA

SBRA has taken the lead in filing writ petitions on issues related to Associate Banks like anomalies in the computation of pension, computation of DA relief in terms of Reg 37 of BPR 1995, participation of the Associate Bank retirees associations for negotiations i.e. Structured Meeting, Notional Seniority to VRS 2001 retirees etc. Since 2019 around 700 letters have been addressed, issued on various subjects, to the Chairman of SBI on behalf of Associate Banks. SBI has a history of not implementing the Court judgements pronounced. This was highlighted to the Chairman, quoting various judgements and unresolved issues. Along with having a dialogue continuously with the Chairman via letters sent, legal recourse also is being pursued. Great efforts have been put till date to educate the legal and statutory provisions of Retiree Associations, which led to a recent meeting organised by SBI Corporate Centre to meet SBRA leadership. This is a great achievement which is a sign of SBI management to consider negotiating with SBRA in eAB retirees-related issues.

### **SBHREA LEGAL FUND:**

We have to report that the Legal fund collected stands at ₹151.23 lakhs and interest earned thereon ₹30.30 lakhs.

The 2 WP's filed in 2020 by SBHREA in the High Court of Telangana regarding Old Pensioners Case and Restoration of Funeral Expenses are still pending for want of counter to be filed by SBI. Constant follow-up is being made with our advocates to expedite them.

The WP's filed by SBRA concerning Notional Seniority for eAB retirees is pending disposal. A contempt case filed in Supreme Court regarding Reg 37 (DA difference), through AIRBEA (SBRA is an affiliate of AIRBEA) is disposed of with a direction to approach the relevant High Court to seek Judgement. SBRA is in the process of filing for DA difference in the High Court.

"Legal Issues Review Committee" formed for the purpose of reviewing all the court cases, fund position is reviewing the fund position, the interest earned on TDRs (accounted separately) periodically. Review of pending court cases and the future requirements of funding the cases

filed, to be filed for new issues will be deliberated periodically by the Committee consisting of GS, DGS, elected Vice President's/ MC members of Hyderabad, Maharashtra, Karnataka, Telangana and Andhra Pradesh and recommendations submitted to the Managing Committee to approve and implement thereupon.

Legal Fund is kept separately and being utilised exclusively to date for meeting legal expenses only. The total legal expenses spent as on 31/03/24 is ₹2.00 lakhs. We assure you all that we are spending the legal fund amount raised judiciously and for the purpose. Here I wish to mention that SBI Pensioners Federation has fought one single case to achieve 40% to 50% of pension to all retirees in Delhi High Court from 2014 to 2022. Their balance sheet shows an expenditure of more than Rs.1 crore spent on this case. This should be an eye-opener to our retirees who contributed to the corpus. We have multiple cases to fight, hence what we hold as Legal Fund is not much to meet the Writ Petitions filed and to be filed.

### WRIT PETITIONS FILED BY SBHREA AND PENDING IN COURTS:

- 1. Old Pensioners case in Telangana High Court
- 2. Funeral expenses case in Telangana High Court
- 3. 5 years Notional Seniority Case in Telangana High Court

### Filed by SBRA on behalf of Associate Banks:

1. Contempt case - Reg 37 filed in 2020, is disposed of with a direction to approach appropriate High Court. Status is Pending filing of petition in High court by SBRA.

There are many more issues are being taken up with SBI Management, if not resolved to be moved to courts.

### **SPECIAL ALLOWANCE AND GRATUITY LITIGATION:**

SBHREA is studying the prospects of winning the Special Allowance counting for Pension and Gratuity Calculations Writ petitions filed by group of petitioners and has decided to take them further, i.e., after the judgement is awarded in the High Court, by impleading SBHREA and pursuing other litigation till the benefit is achieved.

### **MANAGING COMMITTEE MEETINGS:**

The Managing Committee could meet physically once in July'2023 in Hyderabad and yesterday i.e. on 22/06/2024 in Chhatrapati Sambhajinagar. However, virtual meetings were held in between to fill the gap and take timely decisions.

### **BANK PENSIONERS MEETS: 'SAMADHAN PAKHWADA':**

In 2023 bank started taking complaints of all pensioners/ retirees directly in the presence of CDO and concerned officials. 'Samadhan Pakhwada' is conducted every quarter in all circle offices. SBHREA team led the complainants to meetings and followed up the complaints.

In 'Samadhan Pakhwada' meeting held at RBO, Raichur in March 2023, along with individual Retirees complaints, Raichur leader led a team and gave a representation (for second time) for opening of Dispensary/BMO at Raichur. It is under active consideration at RBO level.

### **SBHREM's SCHEME:**

The leaders stationed at Hyderabad and Central Office are constantly being approached by all representatives and members residing outside Hyderabad for follow-up of the bills submitted and we are doing the needful. SBHREA is pursuing PPG Amaravati to advise the balance available in SBHREM's to members annually.

### **SBI HEALTH ASSIST - E PHARMACY SCHEME:**

All elected representatives are helping the members from fresh registration to renewal of SBI Health Assist Policy or registering for E Pharmacy. This being a new concept and renewal given online option, a lot of education was imparted vide numerous messages composed and one-to-one help rendered sitting in office or from home. The minute hospitalisation occurs, one of the elected representatives gets call and from cashless sanction to discharge settlement, the member is given full help. Reaching the local TPA to monitoring the settlement of the final bill is done, making the sick and anxious member reach home happily. This exercise is taken up with full commitment by all 39 leaders of SBHREA.

The pharmacy scheme and medicines supply has lots of problems. We are taking up the above issues with the Insurance Brokers, TPAs and Management at AO/ Circle level. Members are constantly guided to avail of these facilities.

### LIFE CERTIFICATE SUBMISSION:

The system of submission of Life Certificate is made innovative year on year. Our office is open to all members for guidance and doing online submissions for those approaching apart from educating the new circular guidelines. Life of members is made easy by all representatives.

### **SBHREA FELICITATIONS:**

The felicitations were held at various centres and a lot of enthusiasm was shown by organizers and participation was great. Decentralising the felicitation functions and organizing at various centres is well received. SBHREA honouring the pensioners, who are aged 75 years and above, in their nearest stations has fetched good results. Now, almost all retirees' get chance to be honoured. Earlier very few could reach Hyderabad and get the honour of being felicitated. We have honoured as many as 272 Retirees in 2023-24. These functions became like celebrations of SBHREA, enabling many friends and families to meet after a long gap.

### **MEMBERSHIP DRIVE:**

Our Association membership is 6390 retirees and 357 family Pensioners as on 22-06-24. I place on record my sincere appreciations to all the Managing Committee in getting many retirees enrolled as members of our Association. This exercise is to see that all left over members join our family. We earnestly request every member here to bring one non-member retiree, to take this organisation to greater heights.

Membership drive was taken up 3 times by awarding concessional fee, to bring in the left-out retirees. This news is successfully being spread by leaders in different parts of the country. One day we are confident that we shall be able to bring in many more retirees into the SBHREA fold.

### **SBHREA OFFICE PREMISES IN HYDERABAD:**

We wholeheartedly thank the Sri Rajesh Patel, CGM and Sri Rahul Sankritya, CDO, Amaravati Circle for providing additional office space on our request. We profusely thank the Estates Dept., team at Amaravati Circle for all cooperation extended. Our office is open Monday to Friday for members to interact with SBHREA leaders.

### **DONATIONS:**

The only source of income to the Association is membership fee which is decreasing drastically for various reasons beyond our control. Whenever a benefit is derived with efforts of organised struggles of association, reasonable levy is being requested. In 2022 we have given a call for ₹1000/- or more as levy to the DA neutralisation benefitted members. We did this as the arrears were not given from the retrospective date. When Ex-gratia was credited, we gave an appeal for voluntary donations from members, specifically mentioning that there is no compulsion. This decision was taken as the amount of Ex-gratia was never retirees demand and this was a meagre amount. We accepted this with protest and not in lieu of Updation of Pension.

We wholeheartedly thank all the members who contributed whenever there is a call from the Association. This proves your relationship with SBHREA and your confidence in the elected team. We promise to use the funds very prudently and wisely, and in the interest of the Association. The present financial position of our Association is satisfactory. The financial statements enclosed to this report indicate the position of the organisation. Organisation strength is dependent on its financial strength.

We thank wholeheartedly all of you, who are holding the flag of SBHREA high since its birth i.e. from 1986. The list of donors is enclosed.

### **INCOME TAX RETURNS (ITR):**

The ITR for the financial year 2022-23 has been filed. Interest earned has caused Tax liability. Accordingly, we have paid ₹3.96 lakh towards Income Tax for FY 2022-23 and there is a demand of ₹1.56 lakhs as tax payable for FY 2022-23. We are exploring, in consultations with CAs/Tax experts, to either file revised returns or go for appeal.

### **ANNUAL GENERAL BODY MEETINGS:**

The Annual General Body Meetings will be held by rotation in 3 states i.e. Hyderabad (Telangana), Maharashtra and Karnataka. In the Election year, it would be held in Hyderabad as more number of retirees are settled in and around Hyderabad.

### REPORT OF ACTIVITIES ORGANISED BY LEADERS AT THEIR CENTRES:

The organisational activities taken up by leadership stationed at other centres on call are annexed herewith.

### **CONCLUSION:**

We thank our membership wholeheartedly for being with us and reposing full confidence in our decisions. If there are any shortcomings in our functioning, we shall be ready to receive

feedback, rectify and move forward. I eagerly wait to have meaningful deliberations on this report, so that we can improve our performance.

I profusely thank wholeheartedly my President, Working President, Vice Presidents, all office bearers and MC members for their support rendered enabling me to perform.
